Project discussion



Content:

The 3rd TPM was implemented in Hungary according to the attached program; in terms of its genre it was training. The training material is attached (it also forms the basis of a later result).

On the first day, (part of) the participants took part in a ChocolateWorkshop at the ChocoLeaf premises, led by Braun Edit, who is currently studying for a Master's degree in confectionery and chocolate, coffee and tea making (in addition to her existing HR degree). Edit has been working with deviant young people (Műhely Líceum Foundation) and disadvantaged adults, including prisoners, for many years. Váltó-sáv Alapítvány and Állampuszta National Prison jointly implement their project called Chocolate and crime prevention, which includes making artisanal chocolate in a totally closed institution - prison - with the participation of prisoners. The chocolates will be distributed to family members and loved ones of the target group thus strengthening family ties as well as developing several skills during the workshop and providing an interesting programme for the prisoners. They realize that they can also create beautiful and delicious things, which significantly contributes to their self-esteem and self-valuation, thus (also) helping social integration.

Edit taught the participants several techniques that are fast, spectacular, creative and produce tangible results in a short time. Little lasting, let's say, because the whole point of chocolate-based creative programmes is that the finished product – by someone – gets consumed. Because it's delicious. But it's also beautiful and handmade.

The participants actively participated, making beautiful products - proving that even for those who have never worked with chocolate in their lives, the activity is a success.

After a short lunch break, we visited the ArtÉra Foundation's premises, where Puy Tamás, the organisation's leader, presented the activities and operation. Free screenings were available for those who wanted to try them. Everyone could be reassured by the results.

In the evening, during a joint dinner, professional discussions were held about addicts, drug users and the situation of drug use in Hungary.

The next day we visited Vác Strict and Medium Regime Prison. The first item on the agenda was a tour of the institution, where several questions were raised by our Turkish partners. Then we started the actual visit: we visited a 7-person cell, the prisoner's work in the printing house, the prison chapel, the Doberdo Ward and last but not least the finished work of the Picasso project. The interactive nature of the Doberdo Ward, with the opportunity to try out the standing cell as well as the dark cell, was particularly interesting, only surpassed by the wall surface of the Picasso Project, a product of community art. In both cases the feedback from the Turkish partner was very positive.

The weather was extremely hot - 39.5 degrees Celsius in Vác - we tried to cool down a bit on the Danube bank and had lunch despite the heat. The programme also got delayed a little bit everyone was already feeling uncomfortable because of the heat.

The Hungarian participants came back to Budapest by train, the Turkish participants by car. We agreed that everyone would rest and we would continue later - we could do this the next day, because everyone was really tired of the programme and its impulses and impressions on the one hand, and the sweltering heat and the journey on the other.

The next day, we met at the place of operation of Váltó-sáv Alapítvány (office). As the mid-term of the project expired on 30.06.2022, and as we have to submit a progress report by 30.08.2022, the details of this report were mainly discussed. We have organised further short-term programmes, so the Hungarian partner will travel to Turkey for a training on 11-12.08.2022. The topic is still disadvantage, such organisations will present methods and tools (among others there is a project on prison art, social support for children of female prisoners, etc.). The programme will be sent later by the Turkish party.

The provisional date for the bilateral meeting is September (preferably the week starting on 12 September). The Turkish partner is expected to travel with 2 target group members because the planned costs have increased significantly due to world events, i.e. inflation everywhere, travel, accommodation and meals are significantly more than planned. It is likely that 2 target group members will travel with 1 helper. Details are being clarified.

We checked again the project summary ppt used at the first VC to specify what results, objectives, achievements and dissemination we will now have to report on. The basis of the planned material is ready; Crime Stop Foundation will add digital literacy curriculum and the Turkish organisation will write the part for people with physical disabilities.

We evaluated both verbally and in writing (the latter is attached). Verbally, the Turkish partner highlighted the prison visit as the defining experience, as one of the strongest TPM experiences in the last 10 years. Within this, community art and graffiti was again a focus.

We also went through the training material.

All in all, a very meaningful joint work has taken place over the past 2.5 days.
